

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.memyselfandmoney.com and Me Myself and Money and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Me Myself and Money include www.memyselfandmoney.com. The Me Myself and Money website is a corporate site. By using the Me Myself and Money website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Me Myself and Money may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Me Myself and Money collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Me Myself and Money may also use your personally identifiable information to inform you of other products or services available from Me Myself and Money and its affiliates.

Sharing Information with Third Parties

Me Myself and Money does not sell, rent or lease its customer lists to third parties.

Me Myself and Money may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Me Myself and Money, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Me Myself and Money. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Me Myself and Money website.

Use of Cookies

The Me Myself and Money website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Me Myself and Money pages, or register with Me Myself and Money site or services, a cookie helps Me Myself and Money to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on.
